



EARTH WORKS



Earthworks means modification of land surfaces by blading, contouring, ripping, moving, removing, placing or replacing soil or earth, or by excavation, or by cutting or filling operations, including the importation of fill (see definition of clean fill, Zone, earthworks exclude the cultivation of land and the digging of holes for the erection of posts or the planting of trees, landscaped area and gardens. Earthworks - "earth-moving operations carried out by any means for development purposes and includes: -

- (a) Site Clearance;*
- (b) The disturbance of land surfaces by moving, removing, placing or replacing soil, or by excavation or cutting and filling operations;*
- (c) contouring;*
- (d) Road, driveway, and access construction." (ACC Operative Isthmus District Plan).*

- *Brick*
- *Stone*
- *Wood (even though wood was **once** animate)*
- *Metal*






IRRIGATION WORKS


